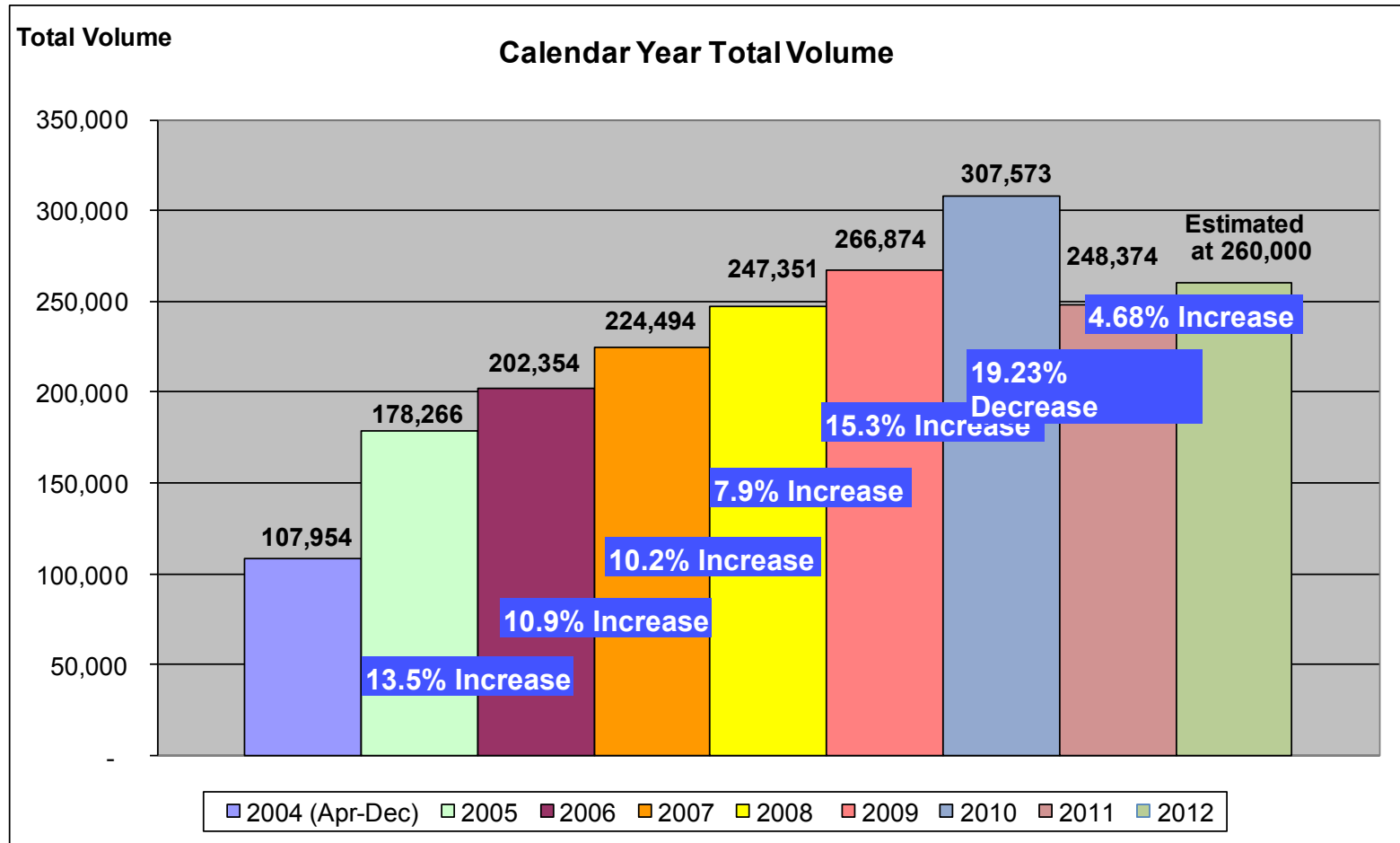

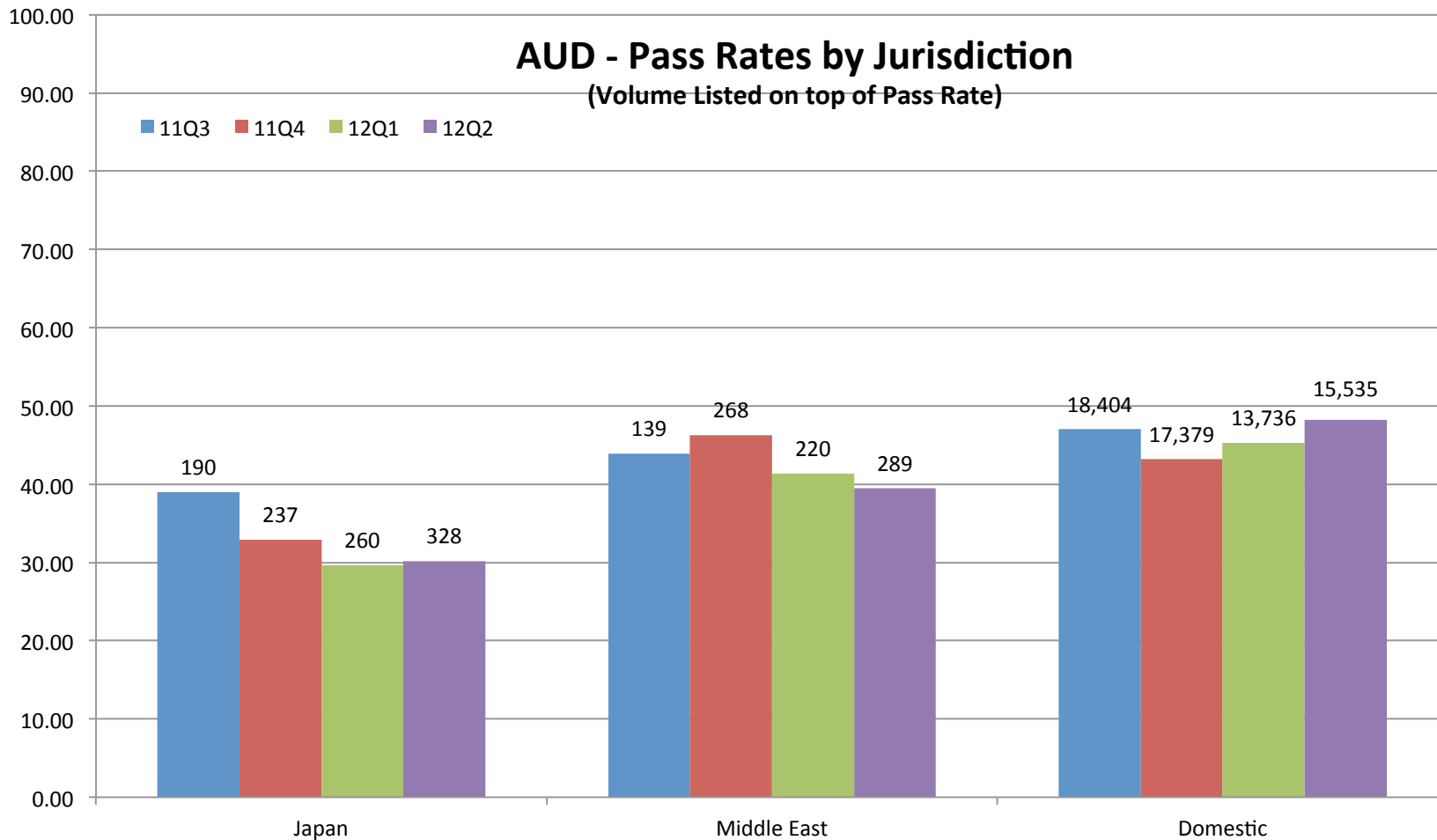
Domestic Volume Chart



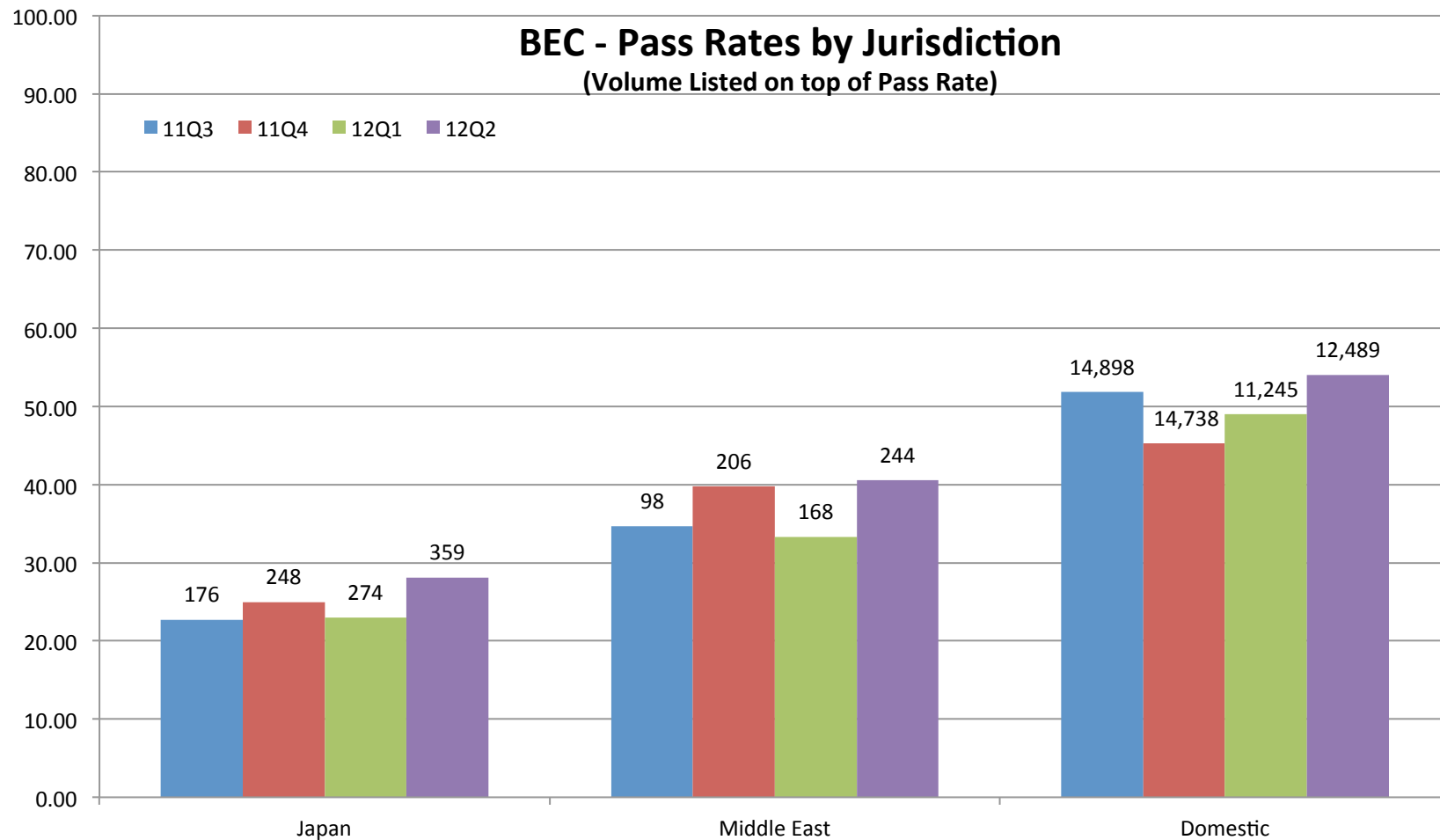

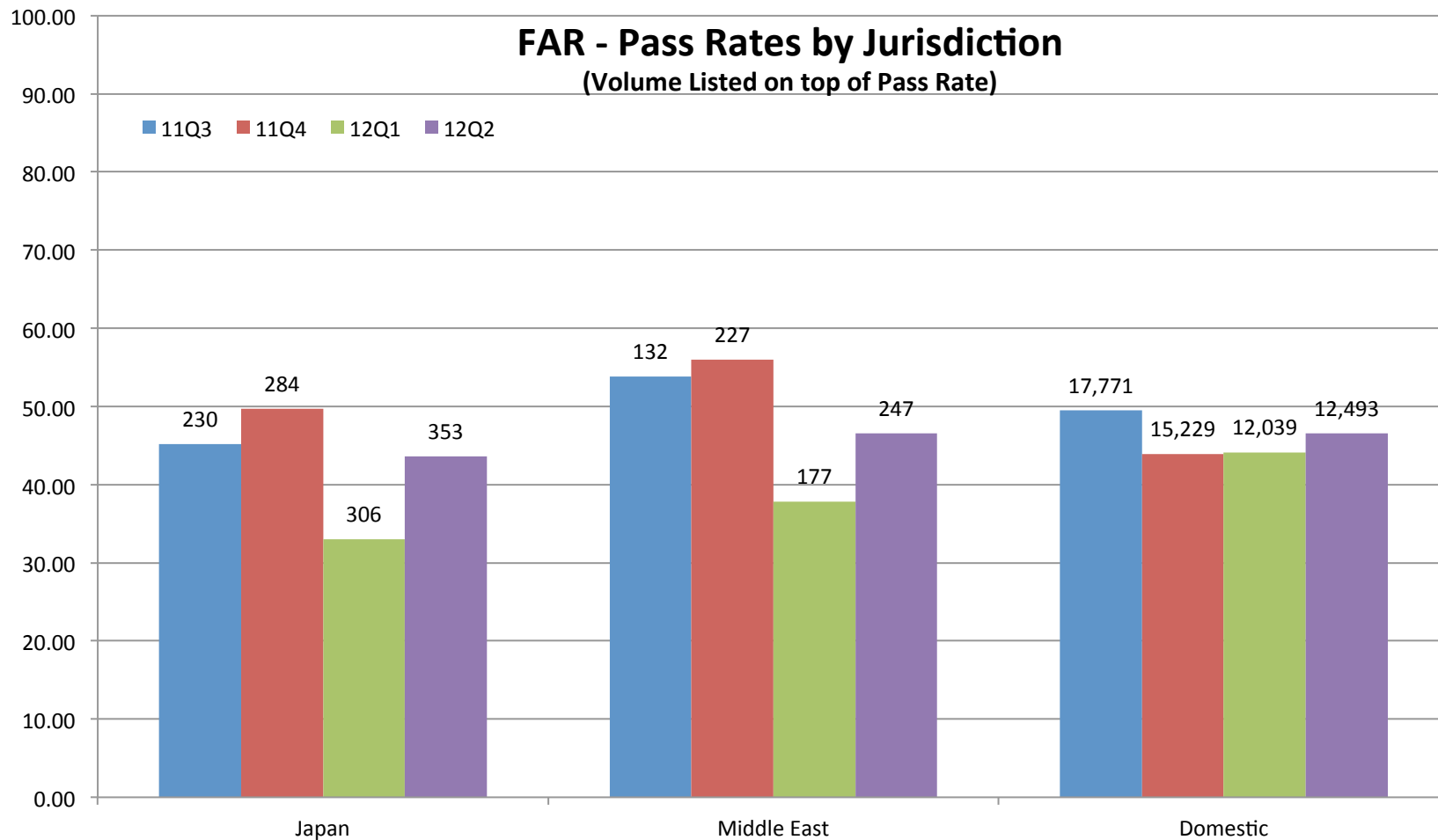
AUD Volumes and Pass Rates 11Q3-12Q2



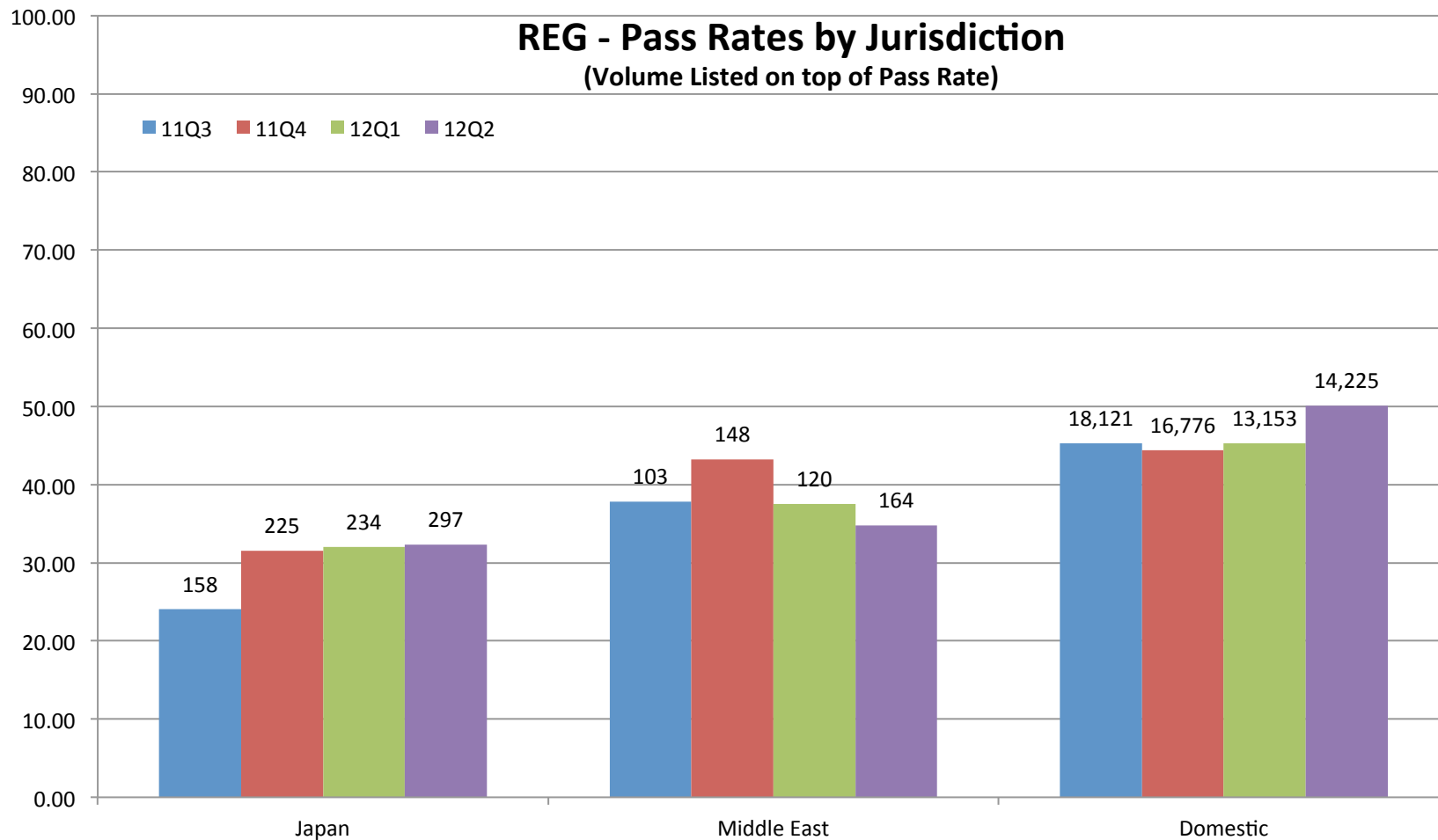
BEC Volumes and Pass Rates 11Q3-12Q2

REG Volumes and Pass Rates 11Q3-12Q2



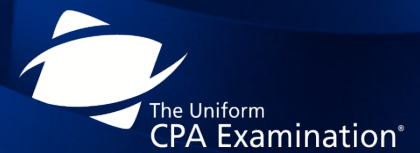
International Qualification Examination (IQEX)

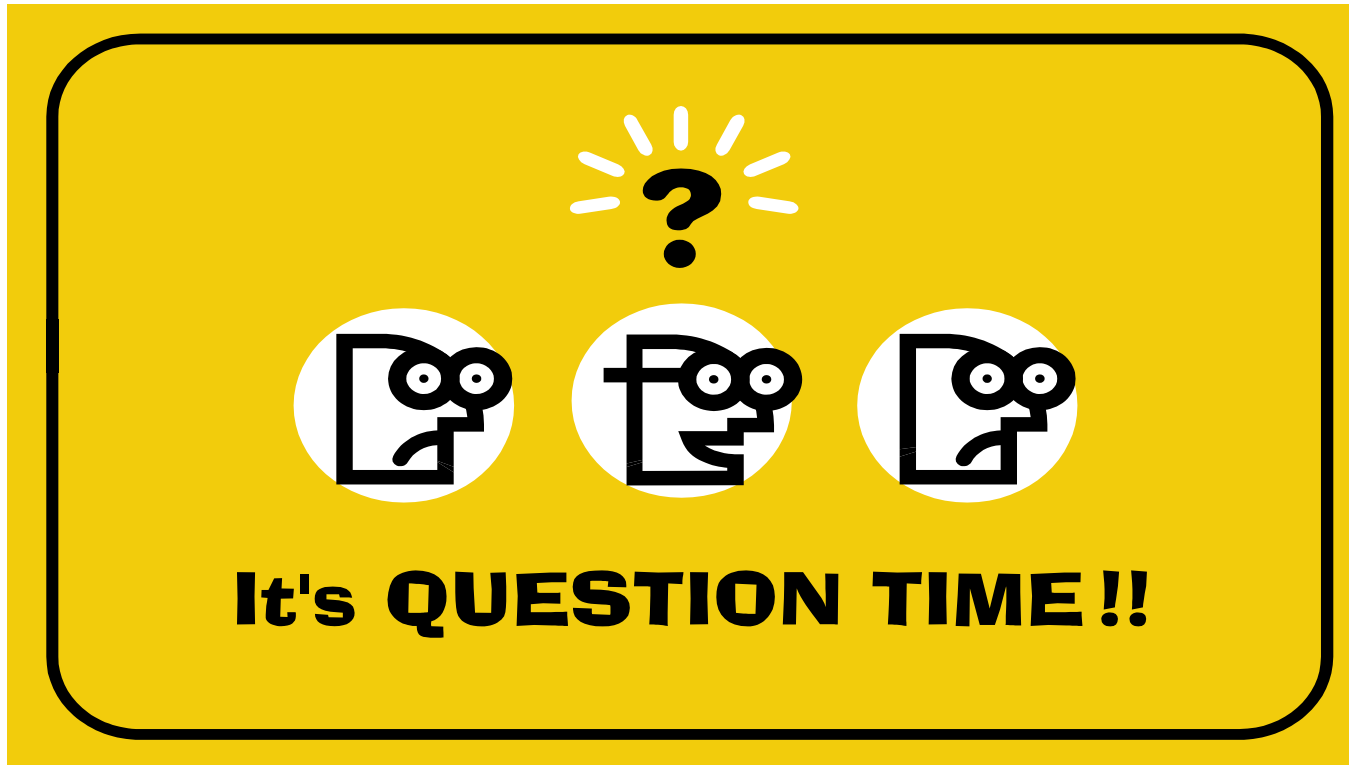
